COLUMBIA-Before you cozy up around your next crackling campfire this fall, make sure you're using locally sourced firewood to protect the forest and trees around you.

October is Firewood Awareness Month, and the South Carolina Department of Parks, Recreation &

Tourism (SCPRT) and South Carolina Forestry Commission (SCFC) are partnering to remind South Carolinians and visitors to "buy it where you burn it."

"Fall is a popular camping season, and as campers move across the state, firewood can easily become a vehicle for spreading non-native, invasive insects and diseases that threaten the health of our forests," said Rachel Snuggs, an SCPRT forester. "When you burn firewood that's sourced from more than 10 miles away, you increase the risk of transporting exotic pests and diseases that can harm the ecology of our local forest systems. These invasive, exotic pests and diseases traveling in our firewood are experts in disguise and have the power to destroy or have a significant negative impact on our forests and economy without being visible to the naked eye."

The threats South Carolina trees and forests are facing from invasive pests are real and ongoing. The USDA has been working to remove thousands of trees in Charleston County that are infested with Asian long horned beetles, which weaken and eventually kill trees. European gypsy moths - known for defoliating trees and leaving them vulnerable to diseases - have been captured in traps set at Huntington Beach State Park. Experts are monitoring and working to suppress these and other invasive insect species, but they can't control the problem alone.

"Asian long horned beetle and European gypsy moth are just two forest pests that are known to be transported on or in firewood," said David Jenkins, Forest Health Coordinator at SCFC. "Emerald ash borer, oak wilt, hemlock woolly adelgid, and sudden oak death can all move on infested or infected firewood. All of these, and many more, could have a devastating impact on one of South Carolina's greatest natural resources; our forests."



Buy It Where You Burn It ... Don't Move Firewood

is:

We can all help protect our forests and mitigate the spread of invasive pests and diseases with one simple step - don't move firewood. While it doesn't completely eliminate the threat to our forests and trees, the easy decision to get firewood at your destination instead of packing it before you leave home can have a huge impact.

Every South Carolina State Park camper, or anyone planning a campfire across the state, can play their part by only using firewood that

Locally sourced. Firewood sourced within 10 miles is best, and firewood from further than 50 miles is too far. South Carolina State Parks sell firewood bundles for campers, and park rangers can offer advice on the best local firewood sources near parks. It's illegal to move firewood from certain parts of neighboring states.

Certified heat-treated. Look for a USDA APHIS heat treatment or South Carolina Department of Agriculture seal. Kiln-dried lumber is not the same as heat treated and doesn't meet the same stringent qualifications.

Gathered on site, where permitted. If you aren't building the campfire on your own property, check with the property owner before gathering fallen branches. Visitors are not permitted to harvest wood on state park property.

COUNTY PLANNERS PUSH FOR AGRICULTURE PRESERVATION DISTRICTS IN LIEU OF DEVELOPMENT MORATORIUM

he Greenville County Planning Commission voted unanimously at its Sept. 22 meeting to recommend amending the county's zoning ordinance to create an agriculture preservation district.

The measure had been proposed by county councilman Joe Dill Sept. 7 in response to a desire among residents in his northern Greenville County district to preserve the rural character of their communities.

The proposal adds language to the county's zoning ordinance defining the agricultural zoning district and spells out acceptable uses for property bearing that zoning designation.

Among the acceptable uses defined in the new language are agritourism, timber production, fishing lakes and ponds, riding academies and animal production, among others.

In making the proposal, Dill said he wanted to give county resi-



dents a means for protecting the rural character of their property. He also said that if the county council approved adding the agricultural preservation district to the county's zoning ordinance, another proposal he put forward — imposing a six-month moratorium on new housing developments — might no longer be necessary.

With the Planning Commission's approval, the measure will go before the county council's Planning and Development Committee next month. If approved there, it will then go before the full council for consideration.

In introducing the proposal to planning commissioners, County Zoning Administrator Joshua Henderson said staff recommended adoption of the measure as it would give county planners an additional tool.

Commission Chairman Steven Bichel said he wholeheartedly supported the measure. Commissioner Mark Jones said that as a farmer in the southern part of the county he has waited a long time for this zoning option to become available.

"After all these years, it is so good to see this," Jones said.

SCTPA Comments: While this approach appears to have positive benefits, it also could lead to unintended consequences impacting agricultural lands and forest lands. This is an approach to limiting conversion of forest and farm lands, but could possibly lend itself to county planners thinking about zoning lands where forestry and agriculture operations are not permitted. Conserving these lands for agriculture and forestry working purposes is a good, not a perfect approach of course, but could place working ag and forestry lands in other zonings in jeopardy.



WHOLESALER CEO SAYS HE'S HAVING TO TURN DOWN TRUCKERS IN THE LABOR SHORTAGE BECAUSE THEY CAN'T PASS DRUG TESTS

- A wholesale CEO said he's had to turn down a painful number of truckers because they can't pass drug tests.
- Drug and alcohol rules are keeping about 72,000 drivers off the road in the US, per government data.
- The rules, which started in 2020, is making it harder to enroll drivers, experts told the NY Post.

The CEO of a food wholesaler said he was turning down some candidates for trucker jobs amid a labor shortage because they couldn't pass drug tests.

Chris Pappas, CEO of Chef's Warehouse, which provides ingredients to restaurants, told the New York Post that he was short about 1,000 drivers. The number of candidates being turned away due to drug tests was "a big enough number that it hurts," he said, without giving more detail.

The rules on vetting truckers were changed in 2020. Under the new driver Drug & Alcohol Clearinghouse system for recording drug and alcohol violations, 72,000 drivers were prohibited from work as of September, per government

data. All employers and truckers must update their records annually and all employers must consult the database before they approve a new driver.

Employees are generally pleased with the new, stricter rules, but industry groups say it has made it harder to enroll new drivers, per the New York Post.

"It's a staggering number of drivers we have lost" because of the rules, Jeremy Reymer, chief executive of industry recruiter DriverReach, told the Post.

Steve Keppler, co-director of Scopelitis Transportation Consulting, said drivers that tested positive were previously able to hop between jobs. "They wouldn't report their previous employer, so a carrier wouldn't pick up on the positive test. The Clearinghouse has stopped that from happening," he said.

The driver shortage has caused delays in food and goods supply at some companies and contributed to backlogs at ports, as ships are unable to offload cargo.

Pappas spoke to the New York Post alongside other trucking executives and industry leaders about the impact of the system on recruitment in the sector.

Overwhelmingly, employers see the rules as a positive for safer roads, but some say there are some inconsistencies in the rules, including the fact that different states have different laws surrounding the use of cannabis, per the Post.

As We See It ... As We Are Seen

The American Loggers Council recently held its 2021 Annual Membership Meeting and Conference in Coeur d'Alene Idaho. Even with the ongoing uncertainty of the Pandemic, 180 timber industry representatives gathered for 3 days of business, seminars, logging operation tours and other events.

Why did logging industry representatives from all four corners, and in between (28 states) attend? Because these industry leaders know that it is the American Loggers Council that represents them and their issues.

Opening the Conference was Idaho Governor Brad Little, who personally attended, formally addressed and welcomed the group, and visited with the attendees.

Why, in his busy schedule did Governor Little attend the Conference? Because he recognizes the value of Idaho's timber industry (not to mention his personal and professional relationship with the Associated Contract Loggers - Idaho, their staff and members) and the role that the American Loggers Council plays in collectively representing the 30 state association members.

Participating in the Conference was Julie Tucker, a representative of the US Forest Service - DC Headquarters Office.

Why did the USFS official attend and participate in the conference? Because the US Forest Service appreciates the collaborative professional relationship between themselves and the American Loggers Council. Additionally, as the PATHH program application deadline approached they knew that directly reaching the 28 states that were represented at the Conference was the most effective way to reach out to loggers and truckers across the country.

While at the Conference, the American Loggers Council received a direct official correspondence from the White House specifically addressing the American Loggers Council, the Conference, and the economic and environmental benefits that the timber industry provides in sustainable forestry.

Why did President Biden reach out to the Ameri-

can Loggers Council during the Conference? Because healthy forests, wildfire mitigation, rural



jobs, and carbon sequestration are not partisan issues. They are shared objectives, and the timber industry, represented by the American Loggers Council, is recognized as being a key element to accomplishing those objectives.

A couple of weeks ago the House Committee on Small Business, Subcommittee on Underserved, Agricultural and Rural Business Development held a Hearing on "Sustainable Forestry's Role in Climate Solutions. Of the four witnesses testifying two were American Loggers Council affiliated. Scott Dane, American Loggers Council Executive Director testified on behalf of the minority party (Republicans) and Dana Doran, Professional Logging Contractors of Maine (American Loggers Council member) Executive Director testified on behalf of the Subcommittee Chairman Jered Golden and the majority party (Democrats).

Why was the American Loggers Council invited to provide Congressional Testimony? Because both parties recognize and respect the fact that the American Loggers Council and its members are necessary to healthy forests, created by science based silvicultural practices performed by the timber industry. The American Loggers Council, Legislative Committee Chairman, Henry Schienebeck (GLTPA Executive Director) testified at a previous Congressional Hearing this past summer as well.

So, "How are WE, the American Loggers Council, Seen?"

We are seen as a leading professional organization that represents the American Logging Industry, speaking on their behalf, and as the National Voice for Professional Loggers.

It's been strange now going on almost two years with the COVID issues for everyone personally and for business. The wood supply chain has functioned miraculously through the COVID times and still functions today. The past years have brought on a myriad of challenges to the timber harvesting and timber trucking segments. I am very proud of how the logging and wood supply sectors operated as an Essential Industries.

2021 has been challenging for the association as well. Through the board's leadership the association has carried on its mission to service and represent the timber harvesting and wood supply businesses in SC.

I want to personally Thank Everyone who renewed their membership in 2021. And also thank the new members who joined during the year. Without the support of members, the association can't operate to serve our industry. Our membership is down from the past. This may be attributed to loggers going out of business and/or retiring, logging business consolidations and changing markets. However, for the most part the association is holding its own.

It's been nice to get back to some sense of normalcy as "live" meetings have taken place to be able to meet and discuss issues. Will we ever get back to the "old normal?" That's a good question to answer. I think we can and just have to adapt to the changing world we live in now.

South Carolina Timber Producers Association continues to represent the timber harvesting sector on many committees such as the SFI State Implementation Committee, SC Sustainable Forestry Teachers Tour Steering Committee, Timber Operations Professional (TOP) Steering Committee, Wood Magic Forest Fair Steering Committee and others.

The association continues working with Southern Loggers Cooperative (SLC) to place more fuel depots around the state. SCTPA acts as the field representative for SLC in SC. SLC has three fuel de-



pots in SC – Allendale, Georgetown and Orange-

burg. Due to the pandemic of 2020 and into 2021, efforts to locate a fuel depot at the WestRock mill in Florence was slowed. However, work is back underway to locate a site near the mill.

SCTPA continues to be a proud charter member of the American Loggers Council (ALC). Active SCTPA logger members automatically are American Loggers Council Members. ALC went through a leadership change in early summer as Danny Dructor retired after serving as ALC Executive Director for twenty years. Scott Dane, formerly of the Minnesota Loggers & Truckers Association, was named the new Executive Director. Scott has the experience and industry knowledge and as well as how the political process works.

ALC has continued to represent America's loggers for federal issues in Washington, DC. Several ALC members and member association executives provided testimonies in hearings in DC during 2021. Efforts to get the Safe Routes Act and Future Logging Careers Act as well as other federal issues have been supported and worked by ALC. SCTPA had individual contact with our SC U.S. House and Senate members in Washington seeking support of the two Acts. I am proud to say both our U.S. Senators and five U.S. House members signed on as cosponsors to the Safe Routes Act. Senator Tim Scott signed on as a sponsor for the Future Logging Careers Act. SCTPA Chairman Bo Bo Seckinger, Seckinger Forest Products, Inc., Hampton serves on the ALC board of directors.

SCTPA attended the ALC 2021 Annual Meeting in Couer d'Alene, Idaho in October. Representing SCTPA were Chairman Bo Bo Seckinger, Seckinger Forest Products, Inc., Hampton, board member Bob Lussier, Great Woods Companies, LLC, Bennettsville and President Crad Jaynes. SCTPA's President participated in the ALC 2021 Spring and Summer board meetings via virtual medium.

At the ALC Annual meeting, SCTPA board member Bob Lussier was introduced as President of (Continued on page 20)

Team Safe Trucking. SCTPA assisted Team Safe Trucking with the development of the Entry Level Driver Training program by being an Educational Sponsor and providing input into the program's development. The Team Safe Trucking Entry Level Driver Training (ELDT) program has been approved by the Federal Motor Carriers Safety Administration as qualified training for the log trucking segment. The ELDT program is available on the Team Safe Trucking internet platform.

SCTPA's President served on the American Loggers Council Logger and Log Hauler Relief Advocacy Committee for the development of a template for the Pandemic Assistance for Loggers and Log Haulers Program (PATHH) to provide the U.S. Department of Agriculture (USDA) guidance on how the PATHH program should run and the criteria for funding to be distributed. USDA used the ALC generated template along with the federal criteria to implement the program. SCTPA had contacts with both SC's U.S. House and Senate members seeking support for a quicker release of the PATHH program. Our DC delegation responded with full support.

In SC's legislative environment, SCTPA continues to support and address SC tort reform for the purposes of revising tort laws to reduce the number and magnitude of lawsuits pursued by the "preying plaintiff's attorneys" against our industry's log truck segment. SCTPA supports the SC Coalition for Lawsuit Reform to enact more tort reform. Tort reform will be a priority for the 2022 SC legislative session.

SCTPA continues to partner with the SC Forestry Commission (SCFC), the Forestry Association of South Carolina (FASC) and SC Trucking Association for issues impacting timber harvesting and transportation.

SCTPA's 2021 Annual Meeting was cancelled due to the COVID-19 pandemic and that hurt the association. Now we are excited our 2022 Annual Meeting will be conducted February 25 – 27, 2022 at the DoubleTree Resort by Hilton Myrtle Beach Oceanfront. Speakers are lined up, registration packages have been sent and we are looking forward to getting back together and conducting a great 2022 Annual Meeting. I hope everyone will come join us.

SCTPA conducted a Strategic Planning meeting

on October 20 to review and plan for the association's future. Forestry Mutual Insurance Company's Keith Biggs and J. P. Dame attended the meeting. Keith served as the meeting facilitator and J. P. provided technical assistance. The meeting held an association Strengths, Weaknesses, Opportunities and Threats session which was very helpful for the board. Some of the focus points from the meeting were the need to increase membership, improve finances, increase member services and plans were discussed for leadership succession of the current association president. Several goals for the next year were set for increasing membership. A new association brochure is available for use to provide to non-members or anyone for that matter. If you would like to receive the brochure to pass along to your non-member peers, just contact SCTPA. The board decided to go to a quarterly Timber Talk publication in 2022 and publish it in color.

SCTPA regular board of directors meeting have been held in 2021 with Forestry Mutual's Keith Biggs, J. P. Dame and Greg Hutson, Swamp Fox Agency's Rick Quagliaroli and guests attending several meetings. Board of Directors meetings are open for any member to attend. Just contact SCTPA for dates or look in Timber Talk magazine.

This has been a quick snapshot as there has been more activities during this year. But I just thought this would be a good way to show your association is working for you.

SCTPA will continue to serve and represent SC's timber harvesting, wood supply and unmanufactured forest products trucking segments for issues impacting our industry.

I want to thank everyone for your membership and thank our board of directors for their leadership. It's been tough on all us with what we've been through. Again I am so proud of our industry's segment, the loggers, wood suppliers and truckers, who are the most important link in the wood supply chain for the jobs you do and for your service to SC's forest products industry.



Infrastructure and Jobs Act Passes U.S. House

ate on Friday, November 5, the U.S. House of Repre-

■ sentatives passed a comprehensive infrastructure package titled the Infrastructure Investment and Jobs Act that passed the U.S. Senate on a bipartisan vote in August.

The measure, which passed the House on a vote of 228-206 (13 Republicans voted for the bill, 6 Democrats voted against), includes over a halftrillion dollars in spending on roads,



ports, bridges, and rail, among other priorities. Included within the 2,740-page bill that will soon be signed by President Biden are a few items of interest to Forest Resources Association and the industry.

- A favorable provision grandfathering existing gross vehicle weight limits on states roads converting to interstate highways. Currently in North Carolina, several state roads are slated to become federal interstates in the near future. Right now, the maximum gross vehicle weight limit on North Carolina state roads is 90,000 pounds for five axle trucks carrying logs and forest products. Once those roads convert to interstates, the weight limit would decrease to 80,000 pounds unless the 90,000-pound standard is grandfathered. Enactment of this bill addresses this issue.
- Authorization for a pilot program allowing young drivers (between 18-21 years old) to operate trucks interstate after completing rigorous operational and safety training. Currently, younger drivers may drive all day every day within a state's borders but may not cross state lines. For the last few years, the provision, known as the DRIVE Safe Act, has been a priority of truckdependent industries as a way of attracting younger drivers to the profession. Related language was also included promoting women in the trucking workforce.
- Language creating a new federal system for subsidizing sawmills and other wood processing facilities, along with \$400 million in new financial assistance. The provision specifies that "close proximity" to a sawmill would become a factor for agencies to consider when funding federal land restoration. One of the ongoing challenges to making thinning projects economical is access to processing facilities. Existing wood processing infrastructure is not in close proximity to many

federal forests that desperately need active management.

- Provisions of the Repairing Existing Public Land by Adding Necessary Trees (REPLANT) Act are included in the bill. The REPLANT Act quadruples investments to support reforestation projects on national forests by removing the current funding cap of \$30 million per year on the Reforestation Trust Fund. This will help the U.S. Forest Service plant 1.2 billion trees on national forests.
- Language establishing a Vehicle Miles Traveled (VMT) fee pilot program. Specifically, the legislation authorizes \$125 million for grants that would enable creation of pilot VMT programs to collect data on whether a VMT is a viable option for replacing the gas tax to fund highway programs. The VMT would apply to both private and commercial vehicles.
- Provisions promoting workforce development in the transportation sector. Specifically, language authorizes grants to educational institutions or state departments of transportation, in partnership with industry, to develop, test, and review new curricula and education programs to train individuals at all levels of the transportation workforce. Further, the new curricula and education programs will provide for hands-on career opportunities to meet current and future needs. There are no details yet on what will qualify on training program front.
- Efficient manufacturing \$2.1 billion in assistance to help manufacturers improve energy, water and material efficiency, load management and onsite generation to reduce waste and pollution while increasing profit. The provision includes a special set aside for small to medium sized manufacturing operations.

This bill does not raise taxes, and instead will take money that had been appropriated, but not used for COVID-19 relief.

Vancouver, B.C. - West Fraser Timber Co. Ltd. ("**West Fraser**" or the "**Company**") (TSX and NYSE: WFG) announced today that it has entered into an agreement to acquire Georgia Pacific's oriented strand board ("OSB") mill near Allendale, South Carolina for approximately \$280 million. The transaction is anticipated to close following successful completion of U.S. regulatory reviews and satisfaction of customary conditions. Management will provide an update and further details about the transaction on West Fraser's third quarter earnings call on October 28, 2021. All dollar amounts in this news release are expressed in U.S. dollars.

The Allendale facility, which initially began producing OSB in 2007, has been idle since late 2019 and has an estimated stated capacity of approximately 760 million square feet (3/8-inch basis). The Company intends to invest an estimated \$70 million of additional capital to upgrade and optimize the facility in preparation for its restart and this upgrade is anticipated to take approximately nine months to complete. The mill is expected to directly employ approximately 135 people and be one of the lowest cost mills in the Company's OSB portfolio after the optimization is complete and the mill has ramped up to full production, a process that typically takes 18-24 months after restart.

Track Record of Mill Restarts and Strategic Rationale

The Allendale acquisition offers another opportunity for West Fraser to create value by deploying the Company's expertise at successfully reinvesting in and restarting idled OSB mills. Recent West Fraser OSB mill restarts include Chambord, Quebec in March 2021 as well as Huguley, Alabama (2017) and Jefferson, Texas (2013). After modernization, the Allendale facility will enhance West Fraser's OSB portfolio with its attractive location in the U.S. South where fibre is abundant and low-cost. The mill's additional OSB capacity will also give West Fraser the flexibility to better meet customer demand, particularly from large, growing end-markets in the southeastern U.S.

"We look forward to acquiring and upgrading the Allendale mill to make it another component of West Fraser's low-cost production portfolio. Further, the additional production capability will provide greater operational flexibility across our OSB mill portfolio to meet demand growth for our engineered wood products, including for our specialty and value-added products," said West Fraser's President and CEO, Ray Ferris. "We have the leadership, people and know-how to execute on the capital and upgrade plan for this mill and expect to be ready for a restart within nine months of the acquisition closing based on current demand conditions."

West Fraser intends to finance the acquisition with cash on hand. The total investment for the Allendale acquisition is expected to be at a significant discount to the costs of an equivalent greenfield OSB mill while requiring a shorter time to initial production. Based on West Fraser's latest internal analysis, the returns of this mill acquisition and investment are expected to be commensurate with those for other capital projects of similar magnitude.

West Fraser is a diversified wood products company with more than 60 facilities in Canada, the United States, the United Kingdom, and Europe. TEAM Safe Trucking to Continue "Trucking On" Under New President Bob Lussier

TEAM Safe Trucking (TST), a well-known strategic partner of FRA, has recently transitioned to a new President. Bob Lussier officially took the reins from Richard Schwab at the group's Annual Meeting in Coeur d'Alene, ID, on October 6. Bob is a secondgeneration logger and timber buyer and brings 38years of experience into his new role. He is actively engaged in numerous professional associations supporting the forest products industry, including serving on the Board of the South Carolina Timber Producers Association and serving as South Carolina's proxy to the American Loggers Council's Board. Bob and his wife, Cindy, own and operate Great Woods Companies, LLC of Bennettsville, SC. TEAM Safe Trucking, Inc. was founded in 2015 as a non-profit group seeking to elevate the standard and performance of the forest products industry's trucking sector.

Last week, I had a conversation with Bob to welcome him into this new role and learn more about his strategy to move TST forward. It is fair to say that Bob has big plans to build on the past accomplishments of TST's leadership team. I would like to share some of the highlights of our discussion.

 Comments on leadership from Miranda Gowell, TEAM Safe Trucking's Special Projects Manager, and Past President, Richard Schwab.

"Miranda has been doing a great job in securing funding and grants for TST, as well as in developing the training modules we have. Richard Schwab has done a super job getting TST to where they are today. I've got a big set of shoes to fill, and I hope I don't let him down. He's a hard act to follow!"

• What motivated you to accept this new challenge?

"My career started in southern New England at a very young age. It brought me to South Carolina 12 years ago. I've experienced tremendous change throughout my career. God has blessed me for over



35 years in this industry and guided me to be successful. I feel it's important to pass the knowledge I have gained and give back to an industry that has been so good to me. When Past President Richard Schwab approached me with this opportunity, I realized it would be a great place to start. We all see the struggles around us, but until we step up, nothing will change. As Crad Jaynes, Executive Director of the South Carolina Timber Producers Association, tells his Board and membership: "If we're not sitting at the table, we're on the menu!"

What is your plan to hit the ground running?

"I'm a business owner, so I know how to lead, direct, and motivate employees. This is a different dynamic so it will be my job to engage the TST Board and various committees to align everyone to get them to help TST have a positive impact on our industry. In the upcoming months I will be reaching out to the Board and committee members to get their input on what needs to be done to bridge the gap between what we have available and what's actually being used. We could possibly recruit some new committee members and rekindle the fire the group had at its inception."

 What are your thoughts on recruiting young professionals into the trucking workforce or associated supply chain?

"FRA, ALC, TST and all of our state organizations all need to work together in Washington DC to get

legislative reform allowing 18-year-old CDL drivers to drive on the interstate. I feel that's important because quite often, by the time a person is 18, they have already made a career decision. I personally feel the Youth Careers Act will help address this. The forest products industry gets in your blood at a young age, as it did for many of the baby boomers that are in it today. The Millennials and Zoomers (Generation Z) haven't been exposed to that. I want to find a way to get them involved at a young age with TST resources to train them and make them safe drivers, and I'm hoping the insurance companies will see the value in them as potential employees."

• The workforce shortage issue is a serious concern for our industry and the nation at large. What are your thoughts on this?

"Our forests are sustainable, and our timber supply is sustainable. However, our workforce is not sustainable, and that's a major problem. You are only as good as the weakest link in your supply chain." Bob further expressed his concerns that these labor shortages have forced many sectors within our industry to operate shifts significantly understaffed and implement a way too "lean" manufacturing process. "You can only trim so much fat within an organization. We can't continue to operate this way."

Miranda Gowell, TEAM Safe Trucking's Safety Director stated that TST is making progress on addressing the workforce shortage issue. Their Entry Level Driver Theory Training Program is a statesponsored program designed to assist with training new drivers set to enter the forest products transportation community. This program will help the transportation industry have a plan in place to meet the FMCSA Regulation set to become effective on February 7, 2022.

• How can FRA assist TEAM Safe Trucking's leadership on accomplishing their goals?

"There's a lot of knowledge and information out there that is not being used. TEAM Safe Trucking is an undervalued and underutilized resource. The information is out there and some of it is free! We need to get this information out there to the people that need it and can benefit from using it. I look forward to teaming up with FRA as one of the key components to bridge the gap with the forest products industry drivers. I feel FRA can help TST because they represent so many different regions of our country. This can help TST better understand the trucking issues that affect these different areas so that we can prioritize and address these problems."

Miranda notes that many TST supporters, including FRA and the Timber Harvesting and Transportation Safety (THATS) Foundation, have financially supported the development of TST programs, actively participated on TST committees, and featured TST's training progress in numerous publications. All of these efforts have helped promote involvement in their programs and activities since 2015. TST is currently reaching 7,000 forest products transportation drivers and owners across the US, primarily due to the hard work of their 93 educational sponsors. TST's goal next year is to reach all forest products transportation business owners and drivers nationwide to ensure everyone is familiar with TST's mission and the transportation fleet resources available to assist our industry with current transportation-related challenges and issues.

Please join me in congratulating Bob on taking on this exciting new challenge. I have no doubt that Bob will continue to grow TEAM Safe Trucking during his term as President, build on the outstanding work that Miranda and Richard have accomplished to date, and help expand TST's footprint across our industry. TEAM Safe Trucking is in great hands, and I look forward to doing my part to help FRA and TST keep the momentum going. And I'll sign off with a few last words from Bob ...

"I look forward to working with FRA and its membership in making TST the go-to resource for the forest products trucking industry."
