Message From SCTPA

ation as well. Through the board's leadership the association has carried on its mission to service and represent the timber harvesting and wood supply businesses in SC.

I want to personally Thank Everyone who renewed their membership in 2021. And also thank the new members who joined during the year. Without the support of members, the association can't operate to serve our industry. Our membership was down from the past. I feel this is attributable to the economic attrition that occurs yearly of loggers going out of business and/or retiring, logging business consolidations and changing markets. However, for the most part the association has held its own for 2021.

It's been nice to get back to some sense of normal-cy as more "live" meetings were held in 2021. But still there was a shortfall in these person to person meetings. But I believe it's coming around. Frankly... I am not a fan of online Zoom meetings, but that's just me because I'm a people person and enjoy seeing folks face to face. Maybe that's the new way of doing business I guess.

South Carolina Timber Producers Association continued to represent the timber harvesting sector on many committees such as the SFI State Implementation Committee, SC Sustainable Forestry Teachers Tour Steering Committee, Timber Operations Professional (TOP) Steering Committee, Wood Magic Forest Fair Steering Committee and others.

The association continues working with Southern Loggers Cooperative (SLC) to place more fuel depots around the state. SCTPA acts as the field representative for SLC in SC. SLC has three fuel depots in SC – Allendale, Georgetown and Orangeburg. Due to the pandemic of 2020 and into 2021, efforts to locate a fuel depot at the WestRock mill in Florence was slowed. However, work is back underway to locate a site near the mill.

SCTPA continues to be a proud charter member of the American Loggers Council (ALC). Active SCTPA logger members automatically are American Loggers Council Members. ALC went through a leadership change in 2021 as Danny Dructor retired after serving as ALC Executive Director for twenty years. Scott Dane, formerly of the Minnesota Loggers & Truckers Association, is now the Executive Director. Scott has the experience and industry knowledge and understands the political processes in Washington, DC as that is where the ALC focus is for the nation's loggers and timber industry.

In fact, ALC now has an office in Washington, DC to

be better situated to continue its advocacy for our nation's loggers to better meet the needs to support or oppose federal legislation impacting the timber and logging industries nationwide.

ALC has continued to represent America's loggers for federal issues in Washington, DC. Several ALC members and member association executives provided testimonies in hearings in DC during 2021. Efforts to get the Safe Routes Act and Future Logging Careers Act as well as other federal issues have been supported and worked by ALC. SCTPA had individual contact with our SC U.S. House and Senate members in Washington seeking support of the two Acts.

I am proud to say both our U.S. Senators and five U.S. House members signed on as co-sponsors to the Safe Routes Act. Senator Tim Scott signed on as a sponsor for the Future Logging Careers Act. SCTPA Chairman Bo Bo Seckinger, Seckinger Forest Products, Inc., Hampton serves on the ALC board of directors.

Through the efforts in 2021 of the ALC Logger and Log Hauler Relief Advocacy Committee, which SCTPA's president was a member, the Pandemic Assistance for Timber Harvesters and Haulers Relief (PATHH) program got included in the pandemic assistance bill passed by Congress and signed by the Biden administration. The committee developed the template for the PATHH program to provide the U.S. Department of Agriculture (USDA) and Farm Service Agency (FSA) guidance on how the PATHH program should run and the criteria for funding to be distributed. USDA used the ALC generated template along with the federal criteria to implement the program.

SCTPA had favorable contacts for support with both SC's U.S. House and Senate members seeking a quicker release of the PATHH program funding by USDA and FSA seeking their support for the program. Our DC delegation responded with full support.

Currently the PATHH funding due to the overwhelming number of applicants nationwide, has reduced the full amount of funding to all approved applicants. The number of applications and approvals exceeded the \$ 200 million allocated in the assistance bill. Currently ALC and our own state association are seeking an additional appropriation to make up the difference for the shortfall in the initial funding so as to make all approved applicants whole for the initial maximum funding amount of \$ 125,000.

Thus far, SCTPA has received positive responses from our SC U.S. House and Senate members for this additional funding appropriation. This additional funding request is based on the fact other assistance

programs received additional funding that led to making up the shortfall in full funding.

SCTPA attended the ALC 2021 Annual Meeting in Couer d'Alene, Idaho in October. Representing SCTPA were Chairman Bo Bo Seckinger, Seckinger Forest Products, Inc., Hampton, board member Bob Lussier, Great Woods Companies, LLC, Bennettsville and President Crad Jaynes. SCTPA's President participated in the ALC 2021 Spring and Summer board meetings via virtual medium.

At the ALC Annual meeting, SCTPA board member Bob Lussier was introduced as President of Team Safe Trucking. SCTPA assisted Team Safe Trucking with the development of the Entry Level Driver Training program by being an Educational Sponsor and providing input into the program's development. The Team Safe Trucking Entry Level Driver Training (ELDT) program has been approved by the Federal Motor Carriers Safety Administration as qualified training for the Commercial Drivers License (CDL) drivers nationwide who want to obtain a new CDL or upgrade their CDL status. This includes the log trucking segment. This federal mandate is effective February 7, 2022. The training requires Theory training, classroom training, and over the road training by approved Federal Motor Carriers Safety Administration registered instructors. The ELDT program is available on the Team Safe Trucking internet platform. The issue our industry is struggling with now is the over the road approved instructors.

In SC's legislative environment, SCTPA continues to support and address SC tort reform for the purposes of revising tort laws to reduce the number and magnitude of lawsuits pursued by the "preying plaintiff's attorneys" against our industry's log truck segment. SCTPA supports the SC Coalition for Lawsuit Reform to enact more tort reform. Tort reform will be a priority for the 2022 SC legislative session.

SCTPA continues to partner with the SC Forestry Commission (SCFC), the Forestry Association of South Carolina (FASC) and SC Trucking Association for issues impacting timber harvesting and transportation.

SCTPA's 2021 Annual Meeting was cancelled due to the Covid-19 pandemic and that hurt the association. Now we are excited our 2022 Annual Meeting will be conducted February 25 – 27, 2022 at the DoubleTree Resort by Hilton Myrtle Beach Oceanfront. Speakers are lined up, registration packages have been sent and we are looking forward to getting back together and conducting a great 2022 Annual Meeting. I hope everyone will come join us.

SCTPA conducted a Strategic Planning meeting on October 20 to review and plan for the association's future. Forestry Mutual Insurance Company's Keith Biggs and J. P. Dame attended the meeting. Keith served as the meeting facilitator and J. P. provided technical assistance. The meeting held an association Strengths, Weaknesses, Opportunities and Threats session which was very helpful for the board.

Some of the focus points from the meeting were the need to increase membership, improve finances, increase member services and plans were discussed for leadership succession of the current association president. Plans are now for the current association's president to seek retirement at the end of 2023 after 24 years of serving the association and our industry.

Several goals for the next year were set for increasing membership. A new association brochure is available for use to provide to non-members or anyone for that matter. If you would like to receive the brochure to pass along to your non-member peers, just contact SCTPA. The board decided to go to a quarterly *Timber Talk* publication in 2022 and publish it in color.

SCTPA was instrumental in working with the SC Department of Transportation and partnered with the Forestry Association of SC (FASC) for the Temporary Logging Road Entrance Encroachment Permit and the Bulk Agricultural Permit to haul 90,000 pounds GVW on state roads. Both programs were joint efforts by the three entities and seem to be working for the benefit of our industry and SCDOT. Initially the Temporary Logging Road Encroachment Permit was too cumbersome and regulatory so without SCTPA and FASC's involvement to modify the program, the initial requirements would have been too stringent and restrictive. It's the involvement of SCTPA and partnering with FASC that lessened the regulatory burden initially imposed.

SCTPA regular board of directors meeting have been held in 2021 with Forestry Mutual's Keith Biggs, J. P. Dame and Greg Hutson, Swamp Fox Agency's Rick Quagliaroli and guests attending several meetings. Board of Directors meetings are open for any member to attend. Just contact SCTPA for dates or look in *Timber Talk* magazine.

This has been a quick look at 2021 and there have been more activities SCTPA was engaged in for the enhancement of our industry. But I just thought this would be a good way to show your association is working for you.

SCTPA will continue to serve and represent SC's








2022 SCTPA ANNUAL MEETING

hile in DC I had the opportunity to visit the National and Capitol Christmas Trees, a symbol of the Christmas season. I reflected upon the many symbolisms that the Christmas tree represents and how it can display the true meaning of Christmas. Of course, the correlation to the logging industry was not missed either.

When I watch my wife decorate the Christmas tree, I can't help but see the picture of our life together

manifested in the ornaments hanging on each branch. Branches themselves that represent the growth of our marriage and family.

There are two bears and a heart that says, "Scott and Melody -1988", the year we met. Then there is a crystal ornament with two doves that is inscribed "Our First Christmas - 1989", the year we were married. In 1992 we added a "Baby's First Christmas" for the birth of our first son, and another "Baby's First Christmas" ornament in 1994 for our second son. Homemade Popsicle stick ornaments with glued on buttons were made by the boys. Sand dollars and seashells hang on the tree from the years we lived on a tropical island. Orna-

ments from other areas mark travels to Maine, Minnesota, and Arizona. The "Nutcracker" ornament is a souvenir from attending the Nutcracker Ballet on Christmas. The ornaments on the Christmas tree chronicle the joyous events or our life and family. We added a new ornament with a "C" which represents our foster son.

The Christmas tree is a symbol of the Christmas Holiday which celebrates the birth of Jesus Christ. The perpetual green of the evergreen represents the eternal life of our Lord and Savior. The Christmas tree lights are for the stars of the universe

created by God. The gifts beneath the tree are worldly tokens of the blessings bestowed upon us, much like the frankincense, gold and myrrh brought as gifts to the baby Jesus.

Many years ago, I was working in the Persian Gulf and made ports of call to Oman, Bahrain and the United Arab Emirates. In the market there was Frankincense and Myrrh for sale. I bought some for Melody as a souvenir and to round out the gifts of Frankin-

> cense, Gold, and Myrrh I bought an Eternity ring that Melody wears as a wedding band. These gifts brought to the baby Jesus represent the following:

• Myrrh is an aromatic gum resin from a small shrubby tree that was used as a healing stimulant and as a burial spice. Myrrh, like Frankincense, also is the sap from a tree that is hardened and then used. However, unlike, Frankincense which is sweet...Myrrh has a bitter taste to it. Myrrh was mostly used to embalm the dead because it had the property to preserve. It was also used as a perfume, an ingredient of holy ointments mentioned in Exodus but its most practical use for Mary & Joseph would

be its medical uses. Lastly, Myrrh represents the bitter cup that Christ had to drink in suffering for our sins and the healing for us that his death brings.

Frankincense is a fragrant gum resin obtained from certain trees, frequently associated with Myrrh. It was used in making of perfume and in sacrifices. Frankincense is made by cutting a tree named "Arbor Thurisfrom" found Persia, Arabia and India. It's like a sap that is gathered and then

dried for 3 months and becomes like a hardened resin or gum. Frankincense is used as a perfume but mostly it was burned as a sweet incense during worship. During the Exodus Aaron would burn Frankincense at the alter as a sweet offering to the Lord. Practically Frankincense would be a familiar smell to baby Jesus as this was the same God that was worshiped in the Old Testament. Symbolically Frankincense represented the divinity of Christ because as mentioned Frankincense was burnt as an offering to God.

• Gold represents kingship. The King that Christ is for us. It also represents the purification process we go through in our trials as a Christian. Gold is one of the only metals that when heated with fire will not lose anything of its nature, weight, color, or any other property. Genuine faith is the same way. And when He tests me, I will come out as pure gold.

COUNTY ADDS AGRICULTURAL ZONING OPTION FOR LANDOWNERS

andowners in Greenville County now have a farmland preservation tool in addition to the Greenville County Historic and Natural Resources Trust reported in October by GSA Business Report.

al Preserva-

Voted in unanimously by Greenville County Council on Nov. 16, the Agricultural Preservation District Zoning classification limits development in prime agricultural area and can be installed only at the request of a landowner in previously unzoned areas of the county.

The amendment allows for farming, forestry, veterinary and agri-tourism uses, as well as single-family residences, bed and breakfasts, group homes and special event facilities under certain conditions. Athletic facilities, cemeteries, communication towers, government facilities, religious institutions and runways are special exemptions to the rule, according to council documents.

"I think it's a great thing," Councilmember Joe Dill said during the meeting. "A lot of unzoned areas have been embogged in the development of this ordinance, and a lot of those [impacted] are here in the audience."

Rows of rural residents stood at Dill's prompting in support of the amendment during the Nov. 16 meeting.

Dill put the amendment forward to the county planning and development committee after his proposed moratorium on all county development floundered earlier this fall.

"That was dead on arrival," Chairman Willis Meadow said about Dill's original moratorium.

"We're not going to do that. Greenville's still going to grow, and it's going to grow because we're willing to support that growth.

Why the Trucker Shortage?

Supply chains are fundamental to the United State's superpowers. Their secret weapons are their workforce, none more so than the truck driver. Commercial and consumer demand make the truck – and the truck driver – the most essential factor.

"Truck driver" is the most common job across most of the country according to the Dept. of Labor. That includes every category of truck — small, medium, large, severe service. So why don't we have enough of them?

The diversity and functions of our economy place great expectations on our skilled highway pilots as they navigate every type of ship imaginable while encountering non-stop obstacles and endure lifestyles about which most folks have no concern. These soldiers' duty is by and large taken for granted - until we experience shortages or must summon convoys of heavy-duty, rapid responders. Despite the rough-neck appearance and image, they are the salt of the earth, unsung heroes, bona fide cultural icons.

Moving goods and services perfectly by truck is impossible. The real world gets in the way, posing inexhaustible, unpredictable, frustrating variables. Profitability necessitates collaboration. Every player and input involved must perform without a hitch for the system to work at maximum velocity and safety. Working through other modes and intermediaries adds complexity and less control, if there's any "control" at all. It's like an orchestra without a conductor.

Getting through the concrete and asphalt jungles in the best of conditions takes patience, discipline, focus, and the right attitude. Drivers encounter the gamut of highway environments each presenting a unique set of challenges every mile, every day. Notice the impatient, hurried and often-distracted car drivers, zig-zag traffic, congestion, weather, obstinate pedestrians and cyclists, animals, construction, inadequate parking, drunks, and accidents, and you clearly realize that even the most skilled truck driver needs a great deal

of luck. Replicating success with great consistency is the real goal.

So when he finishes the job - no matter what or to whom he's hauling – he may be satisfied or relieved, proud or worn-out, and, from time to time, maybe a bit exuberant. Often nobody is there to congratulate, much less cheer him. Most of us have been conditioned to forget the human behind the wheel of the machine.

For local, light-duty driving, just about anyone willing can. But as loads get bigger, heavier, or the distance gets longer or the logistics more complex, the nature of the job demands more skill and a different mindset. So do the rewards.

Economic growth means corresponding, inseparable demand for freight services. CDL holders have an array of sectors within which to work, and a wide range of vehicle types with increasingly sophisticated driver-assist, stress-reduction safety technologies. In this highly regulated seller's market, professional drivers shouldn't have to put up with others' inconveniences, inefficiencies, or inconsiderate treatment that hurt their earnings or self-respect.

The job is not for everybody. It's not for those who lack will or skill. It's not for the lazy or unmotivated. It's not for drug users, or alcohol abusers, the timid, weak, or busy-bodies.

It is a great profession for those with stamina and resilience, for the grinders, the independents, the curious and adventurous. And for those who like to earn a living.

Put together a group of kids and show them a CDL and they may shrug it off. But let a successful businessman subtly reveal his, watch the smiles as it raises eyebrows and impresses his peers. That's a real man – or woman.

So, for would-be drivers, don't let the TV lawyers' reckless mischaracterization of this business and stigmatization of its professionals ruin the image, turning you off and away. They produce nothing. You move everything.

It's time for Americans to give the trucker back his due. Try to imagine anything around you that did not get there by a truck. Trucks deliver everything but BS. By the way, you can't truck from home.

The railroads may have helped make this country great. But it's the truckers that are keeping her that way.

PATHH Program Tax Implications

his is a message received by SCTPA from American Loggers Council Executive Director Scott Dane that addresses the tax implications to businesses that received funding from the Pandemic Assistance for Timber Harvesters and Haulers (PATHH) Program.

The question regarding PATHH payments and how they are handled as per taxable income has been solicited. See the response below provided by Farm Service Agency.

The American Loggers Council does NOT provide this information as tax advice and PATHH recipients should consult a professional tax advisor for opinions.

Are PATHH payments going to be counted as taxable income?

The Farm Service Agency reports PATHH program payments to the Internal Revenue Service and program participants on a CCC-1099-G. This report is a service to help program participants report taxable income. PATHH applicants should consult with the IRS or a tax preparer for any additional questions on how this income impacts the PATHH applicant's business.

Will Farm Service Agency issue a 1099 Form to PATHH applicants?

Farm Service Agency will issue a 1099 Form to a PATHH applicant if the dollar amount received by the PATHH applicant for the year is \$600 or more according to IRS regulations. Farm Service Agency will send out 1099 Forms in mid to late January 2022.

Senator,

The American Loggers Council is pleased to announce that the Pandemic Assistance for Timber Harvesters and Haulers (PATHH) program was an historic and unprecedented success! Unfortunately, the eligible financial assistance exceeded the \$200 million appropriation by almost double.

This need required the Farm Service Agency to adjust and factor the original formula to a point where in many cases the amount of financial assistance was reduced to less than half of what the applicant would have been eligible for. As an example, an applicant that would have been eligible, based on their gross income loss multiplied by 80% (original formula) for \$180,000 would have been limited to the maximum of \$125,000. The new formula, due to the excess request for assistance, limits the maximum to \$75,000 and then applies a multiplier of 70.5% to that figure resulting in a maximum limit of \$52,875. This is 42% of the original formula assistance level.

Additionally, where the original assistance formula would have provided for 80% of the gross revenue loss, the new formula only provides 70.5% of the gross revenue loss.

This level of need is evidence of the economic impact that the COVID-19 Pandemic has had on the American timber industry. Multiple economic analysis reports indicated that the economic loss exceeded \$1 billion. Congress recognized this in appropriating the \$200 million. Now that the real economic need has been verified, and to meet the intent of Congress in providing adequate assistance to this vital industrial sector, a supplemental appropriation of \$185 million (as per Farm Service Agency data) needs to be appropriated.

Additional supplemental appropriations have been provided for other disaster and assistance programs when the demand exceeded the initial funding appropriation.

The American Loggers Council, and the timber industry that we represent, is extremely appreciative of the PATHH program assistance. The program's success has exceeded expectations and has received bi- partisan support in both the Senate and House, as well as Administration support. Unfortunately, the success of the program has also revealed the extent of economic impact, loss and need within the timber industry sector. Therefore, the American Loggers Council respectfully requests an additional supplemental appropriation of \$185 million.

Pandemic Assistance for Timber Harvesters and Haulers (PATHH) Program

Supplemental Funding Request



Executive Summary

The American Loggers Council is pleased to announce that the Pandemic Assistance for Timber Harvesters and Haulers (PATHH) program was an historic and unprecedented success! Unfortunately, the eligible financial assistance exceeded the \$200 million appropriation by almost double.

This need required the Farm Service Agency to adjust and factor the original formula to a point where in many cases the amount of financial assistance was reduced to less than half of what the applicant would have been eligible for. As an example, an applicant that would have been eligible, based on their gross income loss multiplied by 80% (original formula) for \$180,000 would have been limited to the maximum of \$125,000. The new formula, due to the excess request for assistance, limits the maximum to \$75,000 and then applies a multiplier of 70.5% to that figure resulting in a maximum limit of \$52,875. This is 42% of the original formula assistance level.

Additionally, where the original assistance formula would have provided for 80% of the gross revenue loss, the new formula only provides 70.5% of the gross revenue loss.

Additional supplemental appropriations have been provided for other disaster and assistance programs when the demand exceeded the initial funding appropriation.

The American Loggers Council, and the timber industry that we represent, is extremely appreciative of the PATHH program assistance. The program's success has exceeded expectations and has received bipartisan support in both the Senate and House, as well as Administration support. Unfortunately, the success of the program has also revealed the extent of economic impact, loss and need within the timber industry sector. Therefore, the American Loggers Council respectfully requests an additional supplemental appropriation of \$185 million.

History

With the onset of the COVID-19 Pandemic, the timber and forest products industry experienced significant economic losses due to the reduction in demand for many products, particularly office paper, and an overall uncertainty. Mills curtailed production and some closed permanently. (Note: Record lumber prices have not translated into comparable increases in timber (logs) or stumpage (standing timber) prices, and in many instances have resulted in little or no increase)

In an effort to gauge the economic impact the American Loggers Council commissioned an Economic Impact study in 2020 which identified a \$1.8 billion negative economic impact to the timber and forest products industry. The U.S. Forest Service conducted an independent internal economic analysis in 2020 that estimated a \$1 billion negative economic impact to the timber harvesters and haulers sector.

The timber and forest products sector was determined to be an essential service that was necessary to provide health and safety products for consumers. Although in many instances due to market losses, continued operations resulted in significant financial losses to some companies.

In response to these losses, and the threat to the sustainability of this vital infrastructure, which is critical to supporting forest management and healthy forests by reducing wildfires, stabilizing watersheds, protecting wildlife habitat, and economic factors such as rural jobs, Congress appropriated \$200 million to provide assistance through the Pandemic Assistance for Timber Harvesters and Haulers (PATHH) program as part of the 2021 Consolidated Appropriations Act.

The Consolidated Appropriations Act, 2021, authorized this critical assistance for the timber industry. Timber harvesting and hauling businesses that have experienced a gross revenue loss of at least 10% during the period of Jan. 1 and Dec. 1, 2020, compared to the period of Jan. 1 and Dec. 1, 2019 should apply for assistance.

The objective of the PATHH program was to preserve the logging and trucking infrastructure until the effects of the pandemic were no longer a factor. This is a critical objective to avoid a collapse of the infra-

structure which will otherwise prove difficult to rebuild.

"USDA's Pandemic Assistance for Producers initiative promised to get financial assistance to a broader set of producers and today's announcement delivers on that promise," said Secretary Vilsack. "On top of the existing challenges associated with natural disasters and trade, the pandemic caused a major disruption for loggers and timber haulers including lack of access to wood processing mills. This industry plays a critical role in our nation's economy, and we are proud to support these hard-working loggers and truckers as they get back on track."

"Like many facets of the agriculture industry, the logging industry has experienced its share of financial hardships throughout the pandemic," said FSA Administrator Zach Ducheneaux. "We're happy to work with the U.S. Forest Service to develop this new program to provide critically needed support."

"We've heard from loggers and truckers whose livelihoods were significantly impacted this past year by the COVID-19 pandemic, and we are pleased that USDA can help alleviate some of the financial burden," said Forest Service Chief Vicki Christiansen. "I encourage those logging and loghauling businesses hardest hit by the pandemic to learn more about the assistance offered through this new program."

The PATHH program was developed by the USDA and opened for application July 15th, 2021, through October 15th, 2021. During the application period over 5,600 applications were submitted representing \$385 million in eligible assistance determinations. Unfortunately, the need exceeded the available resources by nearly double. As a result, it was necessary to adjust the formula which resulted in financial assistance being reduced to between 42% and 70% of the original formula calculation. As an example, an applicant that was eligible for the maximum assistance (\$125,000) received \$52,875.

Original Assistance Formula:

Payments will be based on the applicant's gross revenue received from Jan. 1, 2019, through Dec. 1, 2019, minus gross revenue received from Jan. 1, 2020, through Dec. 1, 2020, multiplied by 80%. FSA will issue an initial payment equal to the lesser of the calculated payment amount or \$2,000 as applications are approved. A second payment will be made after the signup period has ended based upon remaining PATHH funds. The maximum amount that a person or legal entity may receive directly is \$125,000.

Adjusted Assistance Formula:

Based on the number of actual PATHH applications filed, FSA will be required to lower the payment limitation for PATHH from \$125,000 to \$75,000 and apply a payment factor of 70.5% across all calculated payments to ensure program outlays do not exceed the available funding. These provisions were previously outlined in the event the revenue loss reported exceeded available funding.

Financial data derived from PATHH program applicants verified \$700 million in financial losses from eligible applicants.

Need

This level of need is evidence of the economic impact that the COVID-19 Pandemic has had on the American timber industry. Multiple economic analysis reports indicated that the economic loss exceeded \$1 billion. Congress recognized this in appropriating the \$200 million. Now that the real economic need has been verified, and to meet the intent of Congress in providing adequate assistance to this vital industrial sector, a supplemental appropriation of \$185 million (as per Farm Service Agency data) needs to be appropriated.

Therefore, in order to meet the Congressional Intent of the PATHH program and based on actual need and demand as demonstrated by the over subscribing of the PATHH program, it is necessary to secure supplemental funding in the amount of \$185 million. The American Loggers Council proposes two options as avenues to increase the PATHH program funding to ensure adequate assistance is provided to preserve the logging and trucking infrastructure:

Reprogramming USDA FSA Funding:

Identify FSA program funding that did not "get to ground" and transfer that funding to the PATHH program.

Congressional Appropriation As Part of the 2022 Appropriation Bills

Similar to the 2021 Consolidated Appropriations Act, from which the PATHH program received bi-cameral / bi-partisan support, Congress should include \$185 million as supplemental funding for the PATHH program.

Additionally, the premise for the initial assistance was based on the impacts of the COVID-19 virus experienced between 2019 and 2020. Unfortunately, the virus has evolved and resulted in ongoing infection rates equaling or exceeding those experienced during the first year. Impacts and uncertainty continue to threaten the timber industry. Fully funding the level of assistance needed, as opposed to a partial measure, will provide substantive assistance that will effectively meet the needs and intent of the PATHH program.

Justification

Congressional appropriations for industry specific programs have historically been based on eighty percent (80%) of economic impact (loss). Based on the two economic impact studies (referenced) that would have resulted in \$800 million - \$1.3 billion. The initial \$200 million represents twenty percent (20%) of the lesser estimate. Supplementing the PATHH program with an additional \$185 million, to fully fund the documented need, will result in 40% of actual economic loss. Much less than other industry specific assistance programs.

The jobs represented by the timber industry are rural and in areas that are historically underserved communities. Additionally, as an example, the labor force within the timber industry in the Southeast is comprised of minority populations well in excess of the national population demographics. The leading state recipient of PATHH program assistance was Mississippi. The timber industry in Mississippi is the second largest agricultural commodity with an estimated value of \$1.15 billion. The African American demographics of Mississippi census data identifies 38% of the population as African American. The Mississippi timber industry employs 62,000, including a significant number of minority people of color. Compared to the national percentage of

African American's employed in the logging industry (4%), the employment in Mississippi and much of the Southeast exceeds that by many times. Based on these statistics and data, it is evident that the timber industry supports historically underserved demographics and communities. Therefore, it is important to support the PATHH program which supports these targeted groups.

Preservation of the timber management infrastructure is vital to supporting the environmental benefits achieved through healthy forest management. The timber resource represents an opportunity to reduce fossil fuel, carbon emitting, use by producing renewable fuel from forest-based feedstock as demonstrated with the potential for development of bio-crude, Sustainable Aviation Fuel (SAF) and cellulosic renewable fuels (D-3 and D-7) as per the EPA Renewable Fuel Standard.

Healthy forests require active silvicultural based scientific management. The logging industry is one of the primary tools employed by public and private land managers to achieve healthy forest objectives. Healthy forests sequester more carbon, and forest products capture and store carbon, more than unhealthy forests subject to infestation, mortality, and fire.

As a snapshot of the PATHH program and what the underfunding of the program means to individual states, Mississippi is a good example;

Funded Applications - 389

Total Eligible Assistance - \$33,224,347

Adjusted Assistance Received - \$15,635,025

(A state by state comparison of the same information is attached.)

The additional funding will be applied to previously submitted and approved applications based on the original assistance formula. No new application period would be opened, or applications accepted.

Conclusion

The American Loggers Council, and the timber industry that we represent, is extremely appreciative of the PATHH program assistance. The program's success has exceeded expectations and has received bi-partisan support in both the Senate and House, as well as Administration support. Unfortunately, the success of the program has also revealed the extent of economic impact, loss and need within the timber industry sector. Therefore, the American Loggers Council respectfully requests an additional supplemental appropriation of \$185 million.

Aside from the shortfall in funding, the PATHH program was an unprecedented historic public / private partnership success. The USDA / FSA / USFS effort and response was unparalleled. In fact, as a result the PATHH program team members from the public and private sector have been selected for the prestigious USDA "Chiefs Award."

In an effort to realize the full intended level of assistance, the American Loggers Council respectfully requests Congressional support of this supplemental \$185 million funding request for the PATHH program through reprogramming of USDA funds or inclusion in the 2022 Appropriation Bill.
